The Housing Authority of the City of Los Angeles is accepting online applications for individuals and families to participate in a lottery for a position on the waiting list for its Section 8 Program. The Section 8 Program offers housing assistance to families by paying a portion of their rent to private property owners. Any income-eligible family or individual can apply and someone in your household must have legal residency, even if the legal resident is a minor child. Learn more online at **HACLA.ORG**.

Individuals and families can apply online 24 hours a day, seven days a week, during the two-week application period using a smartphone, computer, or other mobile device with Internet access. No applications will be accepted in-person or by mail or email. For those without a smartphone or Internet-enabled computer or device, free access to computers and the Internet is available at your local Los Angeles City library.

**To apply for the lottery**, you need: a valid email address, phone number, the address where you live (if you have one) and mailing address where you can be contacted; the combined annual income for the household; and the full name, date of birth and Social Security number/ Alien Registration number (if you have one) for the Head of Household and their Spouse/ Co-Head (if applicable).
