2020 Virtual Prevailing Wage Seminars

Due to health and safety concerns during the COVID-19 pandemic, the U.S. Department of Labor’s Wage and Hour Division (“WHD”) will not be hosting in-person Prevailing Wage Seminars in 2020.

The WHD plans to offer virtual prevailing wage seminars to provide training and outreach on topics such as compliance and enforcement of the Davis-Bacon and Related Acts.
